Vocational Support Services:

Vocational Training was provided to 50 Columbus Community Center clients who are able to perform a wide range of process and packaging tasks in the Columbus Production Services (CPS) warehouse, located in West Valley City. Additional training was provided to 41 clients in the Organization's secure shredding facility. Also, training was provided to 38 clients in the Contract Services program, encompassing work at the Intermountain Healthcare Laundry in North Salt Lake and grounds and janitorial work at facilities throughout the Salt Lake Valley. During FY18, the organization provided vocational support services to 129 individuals.

4b (Code:) (Expenses \$ **1,953,554** including grants of\$) (Revenue \$ **2,701,263**)

Residential Services:

Residential services are provided to approximately 62 clients at a time, ranging from medically fragile to reasonably independent in seven facilities located in the Salt Lake area. Some of the residential facilities are staffed 24-hours daily, while other residential facilities are staffed as needed to provide occasional assistance to clients. During FY18, the organization provided residential services to 64 individuals.

Community Employment: The Community Employment department consists of three different programs.

The first one is our Supported Employment program. The Supported Employment staff worked with 82 individuals to find and maintain competitive integrated employment in the community, as well as providing on-going job coaching for client's who are in need of this service.

The second program is the NextWork Autism program. During FY18, this program provided assessments, classes, and employment services to 32 individuals with autism. Continued on Schedule O.
