The Columbus Foundation raises and distributes funds that support community-based vocational and employments services. The "Dignity through Work Scholarship Fund." This fund is targeted for young adults who have completed their public education but who do not have the financial means to continue vocational training that would increase their chances of finding meaningful employment in the community. 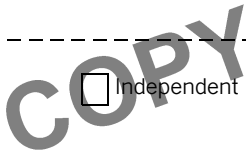
